In the First Person Database is an index to nearly 4,000 collections of letters, diaries, oral histories, and personal narratives in English from around the world, on topics ranging from the Protestant Reformation to the 2003 Iraq War

North American Immigrant Letters, Diaries, and Oral Histories

Database of letters, diaries, oral histories, interviews, and personal narratives of more than 2,000 individuals who immigrated to the United States and Canada between 1800 and 1950

North American Women's Letters and Diaries Database of diaries and letters of 1,325 women from the seventeenth to the twentieth centuries

American National Biography Database of biographies of more than 17,400 men and women who shaped the United States

Dictionary of Irish Biography *Database outlines the careers of prominent men and women born in Ireland and the noteworthy Irish careers of those born outside of Ireland. Contains over 9,000 entries covering 9,700 lives. Biographical subjects include artists, scientists, lawyers, actors, musicians, writers, politicians, criminals and saints.

Marquis *Who's Who on the Web* Database of current biographies of more than 1.4 million individuals who appeared in more than 20 *Who's Who* titles published since 1985, such as *Who's Who in America*, *Who's Who in Entertainment*, and *Who's Who in American Politics*.

Oxford Dictionary of National Biography Database of more than 56,000 biographies of individuals who shaped the history of the British Isles from the earliest times to 2004

Black Thought and Culture Database of more than 1,250 non-fiction sources representing the non-fiction writings of 1,100 leading African Americans

This database does not contain images of the census records, rather statistical characteristics of the population by census or religion.
